on the 4th January 2022 at 7:15 pm in the Methodist Hall

012201 Welcome The Chair welcomed everyone present at the meeting.

012202 Apologies Cllrs, H Hatfield, P Williams and District Cllr Richardson

012203 Public Session

Several residents from The Chestnuts and surrounding areas raised concerns regarding the way the Parish Council had dealt with the Planning Application for Dove Cote Farm. The specific application had not appeared on the agenda for the 30th November and they felt that this had deprived them of the ability to express their objection to the proposal.

It was explained that the agenda had been issued prior to the planning consultation being received and the item was discussed under the standard Planning item that appears on all agendas.

This then raised questions regarding the notice displayed on site which appeared to have been manually amended with a commencement date of consultation of the 17th December 2021 rather than that given to the Parish Council of the 24th November 2021.

A number of issues were then raised by the resident which included concern that the site plan was inaccurate, that The Chestnuts was a private road, that the bus stop was on the frontage of the development and that the school bus picked up children on Field Lane on this section of road.

The Clerk agreed to try to clarify the issue of the commencement date of the consultation, to check the status of The Chestnuts and to pass the concern of the residents to the Planning Authority

drainage problems on Station Road because of National Power Grid works in

the same area.

NYCC had been asked to provide signs for slippery roads but had not

responded.

The Low Cost Housing survey forms are to be issued shortly.

012211 Xmas Lighting It was agreed at the previous meeting that a small group be formed

to review the present arrangements.

012212 Precept for 2022/23 The recommendation from the November meeting that the precept

be set at £ 16,000 was formally approved.

Resolved That the 2022/23 precept be set at £ 16,000.
